Paris 2024 Olympic Games

ARCHERY

1 Definitions and Interpretation

1.1 **Definitions**

Unless otherwise defined below, capitalised terms in this Nomination Criteria have the meaning given to them in the AOC Olympic Team Nomination and Selection By-Law, certain of which have been reproduced below for the sake of convenience.

2024 Olympic Trials or Trials means the National Federation's domestic trials to be held at the AIS Archery Centre in Canberra between 17 January 2024 and 21 January 2024. The trials will comprise of ranking rounds, round robin match play and tournament match play. The final structure of the Trials will be determined and distributed to all athletes eligible to compete at the trials once the number of athletes is known.

2024 Shadow Squad means the squad selected by the National Federation in accordance with clauses 6.3 – 6.5. The 2024 Shadow Squad will be selected at the conclusion of the 2024 Olympic Trials on 21 January 2024 and announced by no later than 31 January 2024.

2024 Shadow Squad Ranking System means the ranking system set out in Appendix 3.

2024 Olympic Team Nomination Ranking System means the ranking system set out in Appendix 3.

AOC means the Australian Olympic Committee Inc and any of its officers, employees or agents and any committee it convenes including the AOC Selection Committee.

AOC Olympic Team Nomination and Selection By-Law means the document adopted by the Executive which governs, among other things, the nomination and selection of Athletes to a Team for an Olympic Games or Olympic Winter Games and which is available at https://www.olympics.com.au/the-aoc/athlete-quidelines/.

AOC Selection Committee means the committee established by the AOC to select athletes to the Australian Olympic Team for the Games.

AOC Selection Criteria means the criteria adopted by the AOC in respect of the Games which outlines the requirements for an athlete to be selected by the AOC to participate in the Games and which appears at Appendix 1 of this Nomination Criteria.

Athlete means a person who:

- (a) participates in the Sport; and
- (b) is recognised by the National Federation or the AOC as eligible for nomination to the AOC for selection to the Team pursuant to this Nomination Criteria.

Executive means the Executive of the AOC.







Extenuating Circumstances means:

- (a) injury or illness;
- (b) equipment failure;
- (c) travel delays;
- (d) bereavement or disability arising from death or serious illness of an immediate family member, which means a spouse, de facto partner, child, parent, grandparent, grandchild or sibling; or
- (e) any other factors considered by the National Federation to constitute extenuating circumstances.

Games means Paris 2024 Olympic Games.

International Federation means World Archery.

National Federation means Archery Australia.

NTSC means the National Teams Selection Committee established by the National Federation to determine the Athletes to be nominated to the AOC for selection to the Team.

Nomination Date means 3 July 2024.

Olympic Preparation Schedule means the schedule of preparation activities set out in Appendix 4.

Performance Period means 1 August 2023 to 31 December 2023.

Qualification System means the eligibility, participation and qualification criteria for the Sport in respect of the Games issued by the International Federation, which can be found at the following URL: https://www.worldarchery.sport/competition/23176/paris-2024-olympic-games-archery-tbc

Sport means Archery.

Sport Entries Deadline means the date on which entries to a Games must be submitted by the AOC, being 8 July 2024.

Team means the team of athletes and officials selected by the AOC to participate in the Sport at the Games.

WA 70/720 means World Archery standard 70m x 72 arrows

1.2 Interpretation

- (a) Unless the context otherwise requires, reference to:
 - (i) a clause is to a clause of this Nomination Criteria;
 - (ii) the singular includes the plural and the converse also applies;
 - (iii) persons include incorporated and unincorporated bodies, partnerships, joint ventures and associations and vice versa and their legal personal representatives, successors and permitted assigns and substitutes; and
 - (iv) a party includes the party's executors, administrators, successors and permitted assigns and substitutes.
- (b) If a person to whom this Nomination Criteria applies consists of more than one person, then this Nomination Criteria binds them jointly and severally.







- (c) A reference to time, day or date is to time, day or date of Sydney, Australia.
- (d) Headings are for convenience only and do not form part of this Nomination Criteria or affect its interpretation.

2 General

- 2.1 This Nomination Criteria is issued by the board of the National Federation. The National Federation must make this Nomination Criteria available to all Athletes participating in the Sport, including by publishing this Nomination Criteria on the National Federation's website.
- 2.2 The National Federation may only nominate Athletes to the AOC in accordance with this Nomination Criteria.
- 2.3 This Nomination Criteria will take effect on and from the date of approval by the AOC and will cease to have effect at the conclusion of the Games.
- 2.4 This Nomination Criteria applies to:
 - (a) all Athletes;
 - (b) the National Federation; and
 - (c) the AOC.
- 2.5 The terms of the AOC Olympic Team Nomination and Selection By-Law are incorporated by reference into this Nomination Criteria. The National Federation must provide, and make available on National Federation's website, the AOC Olympic Team Nomination and Selection By-Law, to all Athletes.

3 Long List

- 3.1 For the purpose only of identifying prospective members of the Team, the National Federation or the AOC may maintain a Long List of Athletes.
- 3.2 For the avoidance of doubt, membership of the National Federation's or the AOC's Long List does not increase, decrease or otherwise affect an Athlete's prospects of being nominated by the National Federation, or being selected by the AOC, to the Team.

4 Athlete Quota Positions

- 4.1 The National Federation may only nominate Athletes to the AOC for selection to the Team where, pursuant to the Qualification System, the International Federation has awarded the AOC or the National Federation athlete quota positions.
- 4.2 A National Federation may not nominate more Athletes than the number of athlete quota positions awarded to the AOC or the National Federation under the Qualification System.
- 4.3 The National Federation may nominate less Athletes than the number of athlete quota positions awarded to the AOC or the National Federation under the Qualification System.

5 Eligibility Criteria

The National Federation will not nominate an Athlete unless, as at the Nomination Date, the National Federation is satisfied on reasonable grounds that the Athlete:

(a) is an Australian citizen;







- (b) is a member of the National Federation;
- (c) will satisfy the Qualification System;
- (d) will satisfy the AOC Selection Criteria set out at Appendix 1 of this Nomination Criteria;
- (e) has not breached the AOC Anti-Doping By-Law, unless the Athlete has been sanctioned for the breach and has completed the sanction imposed;
- (f) does not, and is not likely to in the foreseeable future, suffer from any physical or mental impairment that would prevent the Athlete from competing at the Games to the highest possible standard for that Athlete;
- (g) has attended all competition and training preparation events for the Games to the satisfaction of the NTSC;
- (h) has demonstrated during the Performance Period, a positive contribution with respect to team dynamics, team behaviour and team performance; and
- (i) has demonstrated during the Performance Period, discipline, motivation and commitment to the Sport and to the Team.

6 Nomination Criteria

6.1 The National Federation will use a two-stage process to determine which Athlete(s) are nominated to the AOC for selection to the Team. The first stage of the nomination process will commence with the 2024 Olympic Trials which will be used by the National Federation to select Athletes in the 2024 Shadow Squad. The 2024 Shadow Squad will compete in a series of identified international events to determine which Athlete(s) are eligible to be nominated to the AOC for selection to the Team. The second stage of the nomination process identifies which eligible Athlete(s) from the 2024 Shadow Squad will be nominated for selection to the Team based on the number of quota positions allocated to Australia.

Stage 1 – 2024 Olympic Trials and Olympic Preparation Schedule

- 6.2 The National Federation will select up to 4 Athletes for each gender to form the National Federation's 2024 Shadow Squad based on the results of Athletes at the 2024 Olympic Trials and in accordance with the criteria set out in clauses 6.3 6.5 below.
- 6.3 In order to be eligible for selection to the National Federation's 2024 Shadow Squad, an Athlete must achieve a minimum of 3 Minimum Qualification Scores (*MQS*) set out at Appendix 2 during the Performance Period and must have submitted a registration for the 2024 Olympic Trials in accordance with the method and timeframes set out in Appendix 2.
- 6.4 If two or fewer Athletes of either gender qualify for invitation to the 2024 Olympic Trials, the NTSC reserves the right to invite additional athletes who have not met the requirements set







out in clause 6.3but who, in the sole and absolute opinion of the NTSC, have best meet the criteria in clause 6.3.

- 6.5 At the completion of the Trials, the National Federation will select up to 4 athletes of each gender to form the 2024 Shadow Squad. In determining the Athletes to select to the 2024 Shadow Squad, the National Federation will apply the following considerations:
 - the top 3 ranked Athletes for each gender at the completion of the Trials according to the 2024 Shadow Team Ranking System will be selected to the 2024 Shadow Squad; and
 - (b) a fourth Athlete for each gender may be selected to the 2024 Shadow Squad at the discretion of the National Recurve Coach and the NTSC. In making its determination, the NTSC and the National Recurve Coach may have regard to any, all or none, of the following considerations, in their absolute discretion.
 - i. the Athlete's physical form and fitness;
 - ii. the Athlete's international performances in 2023;
 - iii. the Athlete's performance form based on the MQS events set out at Appendix 2:
 - iv. the Athlete's performance at the 2024 Olympic Trials;
 - v. the level of the Athlete's international experience including events of a similar standard to those expected at the Games;
 - vi. the benefit or detriment of the Athlete's membership on the Team with respect to team dynamics, team behaviour and team performance; and
 - vii. the extent to which the Athlete has demonstrated during the Performance Period, discipline, motivation and commitment to the Sport and to the Team.
- 6.6 The Athletes that comprise the 2024 Shadow Squad must:
 - (a) attend all events included in the Olympic Preparation Schedule set out at Appendix 4; and
 - (b) satisfy the eligibility criteria in clause 5 of this Nomination Criteria (noting that it is acceptable for a member of the 2024 Shadow Squad to be in the process of obtaining Australian citizenship if, in the opinion of the NTSC, there is a strong likelihood of confirmation of Australian citizenship being received before the Nomination Date),

to be eligible for nomination under Stage 2 of this nomination process.

6.7 For the avoidance of doubt, nomination to the AOC is subject to Australia receiving quota places for the individual and/or team events at the Games and Athletes satisfying the relevant criteria for nomination under clauses 6.9 to 6.11.

Stage 2 – Nomination to the AOC for selection to the Team

6.8 At the conclusion of the final event in the Olympic Preparation Schedule, the National Federation will determine the Athlete(s) that are eligible for nomination to the AOC in accordance with clause 5 and this Stage 2 of the nomination process. The NTSC will then







meet to apply the nomination criteria set out in clauses 6.9 to 6.11 to determine the Athletes to be nominated to the AOC for selection to the Team.

Individual Nomination

- 6.9 Where Australia has qualified an individual quota place(s) at the Games pursuant to the Qualification System, the National Federation will nominate Athlete(s) for each gender who, in the opinion of the NTSC, in its absolute discretion:
 - (a) has ranked in the highest position based on the 2024 Olympic Team Nomination Ranking System. For the avoidance of doubt, a ranking of one (1) is the highest ranking possible

Team Nomination

- 6.10 Where Australia has qualified a team quota place at the Games pursuant to the Qualification System, the National Federation will nominate Athletes to the AOC via the recommendations of the NTSC, in accordance with the following process:
 - a) if a team quota place has been awarded to Australia at the 2023 World Archery Championships 1-6 August 2023, Berlin Germany, the first three ranked Athletes using the 2024 Olympic Team Nomination Ranking System as at 23 June 2024 will be nominated:
 - b) if a team quota place has been awarded to Australia at the 2024 Final Team Qualification Tournament (*FTQT*) June 2024, Antalya Turkey, the Athletes that comprise that Australian team will be nominated. The FTQT will be held immediately prior to World Cup 3; and
 - c) if a team quota place has been awarded to Australia through the Team World Ranking List (*TWRL*) after the FTQT and World Cup 3, the Athletes that comprise the Australian team that competed at World Cup 3 will be nominated. World Cup 3 will be held in Antalya, Turkey 18-23 June 2024.

7 Extenuating circumstances

- 7.1 In determining whether an Athlete has satisfied the criteria set out in clauses 5(g) and 6.6(a), the National Federation will have regard to Extenuating Circumstances.
- 7.2 In the event that an Athlete determines that he or she is unable to attend competition and training preparation events for the Games (*Nomination Event*), that Athlete must notify the National Federation of his or her non-attendance in writing as soon as practicable.
- 7.3 The National Federation may consider an Athlete's non-attendance at a Nomination Event to be an Extenuating Circumstance in its absolute discretion. The National Federation may require an Athlete to undergo a medical examination and/or seek additional information or







documentation, as a condition of treating the Athlete's non-attendance at a Nomination Event as an Extenuating Circumstance.

8 Submission of Nominations

- 8.1 The National Federation must notify Athletes of the Nomination Date in writing.
- The AOC may, in its absolute discretion extend the Nomination Date for the National Federation for any reason.
- 8.3 The National Federation must nominate Athletes to the AOC by the Nomination Date. The National Federation must inform Athletes of their nomination or non-nomination by no later than:
 - (a) 48 hours prior to the Nomination Date, where such written notice would be received by the Athlete 14 days prior to the Sport Entries Deadline; or
 - (b) 24 hours prior to the Nomination Date, where such written notice would be received by the Athlete within 14 days of the Sport Entries Deadline,

or such later date as the AOC advises the National Federation.

- 8.4 Nominations submitted to the AOC must be in the form prescribed by the AOC or in a form that is otherwise acceptable to the AOC and include any such information that is required pursuant to the AOC Olympic Team Nomination and Selection By-Law.
- 8.5 The AOC may, in its absolute discretion, accept a nomination submitted after the Nomination Date where it is submitted by the National Federation as a result of an appeal brought in accordance with the AOC Olympic Team Nomination and Selection By-Law.

9 Amendments

- 9.1 This Nomination Criteria may only be amended with the written consent of the AOC.
- 9.2 The AOC may amend the AOC Selection Criteria from time to time in its absolute discretion. If advised by the AOC of such an amendment, the National Federation must update Appendix 1 to this Nomination Criteria and re-upload an updated Nomination Criteria to the National Federation's website and advise Athletes of the amendment.
- 9.3 Where the AOC forms a reasonable opinion that this Nomination Criteria requires amendment, the AOC must notify the National Federation of the required amendments. The National Federation must work collaboratively with the AOC in good faith to amend this Nomination Criteria to the satisfaction of the AOC.

10 Appeals

10.1 A non-nominated athlete may only appeal against their non-nomination to the AOC (Nomination Appeal) in accordance with the procedure set out in clause 9.6 or clause 9.9 of the AOC Olympic Team Nomination and Selection By-Law (the AOC By-Law). For clarity, an athlete who is not selected to the National Federation's 2024 Shadow Squad cannot appeal against their non-selection under the procedure set out in the AOC By-Law, however such an







athlete is able to appeal in accordance with the Archery Australia National Team Selection Appeal Procedure available at https://archery.org.au/governance/.

Any Nomination Appeal arising out of these Nomination Criteria which is commenced under clause 9.6 of the AOC By-Law will be heard by the NST General Division in accordance with clause 9.6(c) of the AOC By-Law. For clarity, clause 10.2 does not apply to appeals against non-nomination commenced under clause 9.9 of the AOC By-Law (Nomination Fast Track Appeal).

11 Governing Law

This Nomination Criteria is governed by the laws of the State of New South Wales.

12 Priority of Documents

To the extent of any inconsistency, the following documents shall be given the following descending order of precedence:

- (a) the AOC Constitution;
- (b) the AOC Olympic Team Nomination and Selection By-Law (including AOC Selection Criteria); and
- (c) this Nomination Criteria.







Appendix 1 – AOC Selection Criteria







AOC SELECTION CRITERIA

PARIS 2024

The AOC has adopted this Selection Criteria pursuant to the AOC's Olympic Team Selection By-Law. This criterion governs the selection of athletes to the Games by the AOC.

1 / Eligibility for Selection

An athlete who is nominated by a National Federation for selection to the Team (*Nominated Athlete*) must satisfy the following selection criteria in order to be selected by the AOC. A Nominated Athlete must:

- A. have met the requirements of the Qualification System applying to the Nominated Athlete's sport;
- B. have satisfied the Nomination Criteria adopted by their National Federation applying to the Nominated Athlete's sport;
- C. have been nominated to the AOC by their National Federation;
- D. have met and continue to meet the eligibility requirements for Australian competitors outlined in the Olympic Charter;
- E. meet the requirements of rules 40 and 41 of the Olympic Charter;
- F. have signed and will comply with the Team Membership Agreement for Athletes for the Games and agree to sign any entry form required by the International Olympic Committee, AOC or the Organising Committee for the Games;
- G. complied with the AOC Constitution;
- H. not have breached the AOC Anti-Doping By-Law or any other By-Law adopted by the AOC from time to time, unless the Nominated Athlete has been sanctioned for the breach and has completed the sanction imposed;
- have been available for sample collection for the purpose of conducting anti-doping testing and have provided accurate and up to date whereabouts information within the 3-strike policy allowed for athletes under the World Anti-Doping Code;
- J. have, if required by the AOC, signed a statutory declaration regarding child protection, antidoping matters and any other matter determined by the AOC to require declaration from time to time:
- K. not at any time have engaged in conduct (whether publicly known or not), which
 - i has brought, brings or would have the tendency to bring the Nominated Athlete or their sport into disrepute or censure; or
 - ii is or would have the tendency to be inconsistent with, contrary to or prejudicial to the best interests, reputation or values of the AOC or Team Sponsors, or as a result of which, the Nominated Athlete's continued membership would not be or would not likely be in the best interests of the Team;

- L. not at any time been charged with any offence involving violence, alcohol or drugs, Child Abuse, any sex offence, or any offence relating to any betting or gambling activities on sport, or any offence which is punishable by imprisonment (unless such charges have subsequently been withdrawn or the offences have been found to be not proven)
- M. not at any time been convicted of any offence involving violence, Child Abuse, alcohol or drugs, or any sex offence, or any offence relating to any betting or gambling activities on sport, or any offence which is punishable by imprisonment;
- N. have disclosed any criminal offence of whatever nature, with which the Nominated Athlete has been charged, or of which the Nominated Athlete has been convicted, and has consented to the Nominated Athlete's National Federation and the AOC making enquiries to relevant authorities for any details of the Nominated Athlete's criminal record (if any), including details of any charges pending or any spent convictions disclosable by law, and consents to those authorities providing that information in answer to those enquiries;
- O. have and must continue to honestly and fully disclose until the end of the Games Period information concerning any conduct that would cause an actual or potential breach of clauses 1(A) 1(N), to their National Federation and the AOC, and consent to:
 - (a) their National Federation and the AOC making enquiries with relevant authorities regarding any disclosures; and
 - (b) consent to relevant authorities providing information to their National Federation and the AOC in relation to those enquiries; and
- P. have completed or will complete medical assessments to the satisfaction of the AOC, if required.

A breach of, or a failure by a Nominated Athlete to comply with clauses 1(A) - (P) may render that Nominated Athlete ineligible for selection to the Team, at the complete and absolute discretion of the AOC.

2 / Selection

The AOC has the sole and absolute discretion to determine:

- A. whether a Nominated Athlete has met the requirements of this Selection Criteria;
- B. whether a Nominated Athlete is eligible for selection to the Team, having regard to the requirements of this Selection Criteria and any other circumstances or criteria the AOC considers appropriate;
- C. that a Nominated Athlete is ineligible for selection to the Team for any reason (irrespective of whether the Nominated Athlete has met some or all of the requirements of this Selection Criteria); and
- D. whether it will select the maximum number of athletes (or teams, where applicable) permitted for selection by the AOC under a Qualification System, regardless of how many Nominated Athletes meet the standards required under that Qualification System.

3 / No Extenuating Circumstances

In determining whether a Nominated Athlete has met the requirements for selection to the Team, the AOC will not have regard to any extenuating circumstances.

For the purposes of this clause, "**extenuating circumstances**" means an inability to compete in, or attend, events, trials, training camps or other competitions arising from:

- (a) injury or illness;
- (b) equipment failure;
- (c) travel delays;
- (d) bereavement or disability arising from death or serious illness of an immediate family member, which means a spouse, de facto partner, child, parent, grandparent, grandchild or sibling; or
- (e) any other factor or reason that is considered by AOC to constitute extenuating circumstances.

4 / Amendments

This Selection Criteria may be amended by the AOC from time to time.

5 / Interpretation

Headings are for convenience only and do not affect interpretation. The following rules apply unless the context requires otherwise.

Unless otherwise defined in this Selection Criteria, capitalised terms used in this Selection Criteria have the meaning ascribed to them in the AOC Olympic Team Nomination and Selection By-Law.

AOC Olympic Team Nomination and Selection By-Law means the AOC Olympic Team Nomination and Selection By-Law adopted by the AOC that is in force and amended from time to time, available at https://www.olympics.com.au/the-aoc/governance/.

AOC Anti-Doping By-Law means the Anti-Doping By-Law adopted by the AOC that is in force and amended from time to time and available at https://www.olympics.com.au/the-aoc/governance/.

AOC Ethical Behaviour By-Law means the AOC Ethical Behaviour By-Law adopted by the AOC that is in force and amended from time to time, available at https://www.olympics.com.au/the-aoc/governance/.

Child means a person aged under the age of 18 years.

Child Abuse means physical, emotional, psychological, harming or exploitation of children, whether in person or online, whether a one-off incident or a series of incidents, whether sexual or otherwise and includes, but not limited to:

- (a) derogatory or inappropriate behaviour;
- (b) non-accidental injury to children;

- (c) inappropriate touching;
- (d) physical, emotional, psychological or sexual abuse including groomed or forced involvement in sexual behaviour, verbal or physical conduct or gesture of a sexual nature (e.g. the use of offensive stereotypes based on gender, sexual jokes, threats, intimidation):
- (e) insensitivity towards children with cultural or religious differences; or
- (f) neglect of an individual, being the failure of a person with a duty of care towards another person to provide a minimum level of care to that person, which is causing harm, allowing harm to be caused, or creating an imminent danger of harm

Games means the Paris 2024 Olympic Games.

Games Period means the period of time between the Sport Entries Deadline and the date that is three days after the "Closing Ceremony" of that Games.

Team means the team of athletes and officials selection and appointed, respectively, by the AOC to participate in the Games.

Team Membership Agreement means the AOC Team Membership Agreement for Athletes which governs athletes' participation in the Games.

Team Sponsors means the sponsors, suppliers and licensees of the AOC and/or the Team.

- A. A reference to a clause or schedule is to a clause or schedule of this Selection Criteria.
- B. The singular includes the plural and the converse also applies.
- C. A reference to an agreement or document (including a reference to this agreement) is to the agreement or document as amended, supplemented, novated or replaced, except to the extent prohibited by this agreement or that other agreement or document, and includes the recitals and schedules to that agreement or document.
- D. A reference to a party to this Agreement or another agreement or document includes the party's successors, permitted substitutes and permitted assigns (and, where applicable, the party's legal personal representatives).
- E. A reference to conduct includes an omission, statement or undertaking, whether or not in writing.
- F. A reference to time is to Sydney time, unless otherwise stated.
- G. Mentioning anything after includes, including, for example or similar expressions does not limit what else might be included.

6 / Law

This document is governed by the laws applicable in the State of New South Wales.



Appendix 2 - MQS Performance

MQS Performance

The Minimum Qualification Score for each gender is as follows:

Category	MQS
Male Recurve	655
Female Recurve	640

Athletes must achieve a minimum of 3 MQS scores during the Performance Period and submit these scores at the time an Athlete registers with Archery Australia for the 2024 Olympic Trials. Registrations can be submitted via email to graeme.rose@archery.org.au at any stage during the Performance Period and must be received by no later than 11.59pm 31 December 2023.

For the avoidance of doubt these are WA 70/720 rounds and can only be obtained for a round shot in the following events provided they fall within the Performance Period:

- a) 2023 National Australian Open/National Target Championships and 2023 State/Territory Championships;
- b) 2023 Pacific Games, 2023 World Archery Championships, 2023 World University Games and 2023 World Cup 4;
- c) events registered on Archers Diary which are clearly titled QRE; and
- d) any other events and tournament registered in Archers Diary that is approved by the NTSC at least 7 days prior to the event, with a copy of the completed scoresheet submitted to the NTSC within 7 days of the event being held.







Appendix 3 – Ranking Systems

2024 Shadow Squad Ranking System

At the completion of the 2024 Olympic Trials (**Trials**), Athletes will be ranked according to their points accumulated over the course of the Trials. For the avoidance of doubt, the aim is to accrue the highest points tally as possible during the Trials, so that more points accrued (compared to another athlete) equals a better ranking.

All scoring during the Trials will be cumulative and calculated in the following manner:

- a) ranking rounds the points scored in each round shall be the number of points accrued;
- b) match play all matches will be 5 sets. The aggregate of the arrow points scored in the 5 sets of a match will be added to each Athlete's cumulative score. Tie break arrows will not be included in cumulative scores;
- match play the winner of each match will be determined using the International Federation's scoring system and the winner will receive 4 bonus points. If a match is won in 3 or 4 sets, additional sets will be shot and the respective set scores added to each athlete's aggregate points total;
- d) match play (male) Athletes will receive a bonus of 2 points for every score of 28 or greater in each set of a match;
- e) match play (female) Athletes will receive a bonus of 2 points for every score of 27 or greater in each set of a match.

In the event that two or more Athletes from the same gender have achieved the same aggregate score at the conclusion of the Trials, any tie will be broken in the following manner and order;

- a) the Athlete with the higher single ranking round score shall be ranked higher;
- b) if a tie remains after applying clause (a) above, the Athlete who has won the most matches during the Trials shall be ranked higher;
- c) if a tie still remains after applying clauses (a) and (b), the Athlete who has won the most bonus points during the Trials shall be ranked higher;
- d) if after applying all of the above tie breakers a tie still remains, a 1 match tie break will be held to finalise the rankings with the winner determined using the International Federation's scoring system.

2024 Olympic Team Nomination Ranking System

- 1. Subject to clause 6, Athletes will be ranked using the arrow average from the first two events set out in the Olympic Preparation Schedule in Appendix 4. The arrow averages will be calculated using all scoring arrows from:
 - a) ranking rounds;
 - b) individual match play;
 - c) teams match play; and
 - d) mixed team match play.







- The top three ranked athletes from each gender after the first two events set out in the Olympic
 Preparation Schedule in Appendix 4 will be selected as the Australian team to compete at the 2024
 Final Qualification Tournament (FQT) and World Cup 3 in Antalya, Turkey.
- 3. In the event that two or more Athletes from the same gender have achieved the same arrow average after the first two events set out in the Olympic Preparation Schedule in Appendix 4, any tie will be broken in the following manner and order:
 - a) the Athlete with the highest single ranking round score over the two events shall be ranked higher;
 - b) if a tie remains after applying clause (a) above, the Athlete who has won the most matches over the two events shall be ranked higher;
 - c) if after applying all of the above tie breakers a tie still remains, the athlete who ranked higher at the 2024 Olympic Trials shall be ranked higher.
- 4. At the conclusion of World Cup 3 in Antalya, Turkey and subject to clause 6, these three Athletes from each gender will be ranked using the 2024 Olympic Team Nomination Ranking System using the arrow average from all four events set out in the Olympic Preparation Schedule in Appendix 4. The arrow averages will be calculated using all scoring arrows at each event from:
 - a) ranking rounds;
 - b) individual match play;
 - c) teams match play; and
 - d) mixed team match play.
- 5. In the event that two or more Athletes from the same gender have achieved the same arrow average at the conclusion of all four events set out in the Olympic Preparation Schedule in Appendix 4, any tie will be broken in the following manner and order;
 - a) the Athlete with the higher single ranking round score from the FQT or World Cup 3 shall be ranked higher;
 - b) if a tie remains after applying clause (a) above, the Athlete who has won the most matches over the FQT and World Cup 3 events shall be ranked higher; and
 - c) if after applying all of the above tie breakers a tie still remains, the athlete who ranked higher at the 2024 Olympic Trials shall be ranked higher
- 6. Any Athlete who wins a gold medal at a 2024 World Cup or the FQT will be ranked first. If more than one Athlete wins a gold medal, the 2024 Olympic Team Nomination Ranking System using arrow averages will be applied.







Appendix 4 – Olympic Preparation Schedule

All athletes selected in the 2024 Shadow Squad must commit to all preparation activities including, but not limited to, the 2024 events set out below in this Appendix 4, training camps and any activity deemed by the Olympic Coach to be necessary in the pursuit of Olympic quotas and Olympic medals. The mandatory 2024 events are:

- o 2024 World Cup 1, Shanghai China, 23-28 April 2024
- o 2024 World Cup 2, Yecheon Korea, 21-26 May 2024
- o 2024 Final Team Qualification Tournament, Antalya Turkey, 14-17 June 2024
- o 2024 World Cup 3, Antalya Turkey, 18-23 June 2024

The dates of required training camps and any other activity will be communicated to the Athletes by the National Federation with reasonable notice.
